BC Regulator Halts Mandatory RNG Hookups, Sparks Energy Debate

The BC Utilities Commission rejected FortisBC's proposal for mandatory renewable natural gas (RNG) hookups for new buildings, citing "undue price discrimination" and concerns about the fairness and feasibility of the plan. The decision reflects broader discussions about the role of RNG in achieving greenhouse gas reduction targets and the need for more sustainable energy solutions.

Non-Res Capital Spending on the Rise into 2025

The latest survey by Statistics Canada shows a promising increase in non-residential capital and repair expenditures, with a significant upward revision for 2023 led by the mining, quarrying, and oil and gas extraction sectors. This positive trend is expected to continue into 2024 and 2025, supported by rising corporate profits and investor confidence, marking a gradual improvement in the outlook for non-residential capital spending.

Federal Minimum Wage Hike to \$17.30

The federal minimum wage in Canada is set to increase to \$17.30 per hour on April 1, up from \$16.65, in response to the rise in the annual average consumer price index for 2023. This adjustment, affecting approximately 30,000 employees in the federally regulated private sector, is part of an annual review based on Canada's consumer price index.

Investing in Northwest BC: A \$250 Million Boost for Critical Infrastructure

The Government of British Columbia has announced a new funding agreement allocating \$250 million over five years to 21 local governments in the northwest region through the Northwest BC Resource Benefits Alliance. This funding aims to support infrastructure construction and the renewal or replacement of capital assets for core public services, such as roads, water, and sewer systems.
